

**Application for Youths from Moose Families**  
**YELLOWSTONE YOUTH CONSERVATION CORPS**

Yellowstone National Park's YCC is a well-balanced, work-learn-earn, eight-week, equal-opportunity summer employment program with a healthy, outdoor atmosphere that builds appreciation of the park's environment and heritage. About 32 applicants, an even number of young men and women, are selected as participants. Typically four are from Mooseheart, three from Moose families at-large, and 25 from the U.S. at-large. In small weekly crews, they do hard physical work, such as trail construction, backcountry cabin restoration, area revegetation and rehabilitation, and maintenance of trails, fences, campgrounds and buildings. They may face difficult working conditions, such as adverse weather and the effects of a high-altitude, mountainous terrain. Participants work a 40-hour week at the U.S. Federal minimum wage, minus standard deductions for room and board. The Yellowstone YCC is fully funded by the Moose fraternity and is administered by officials of the National Park Service.

**An Applicant is eligible if he or she:**

1. Is a U.S. resident aged 15-18 or Canadian resident aged 18 during the period between June 15-August 15, 2005 to 2007;
2. Has no history of serious, safety-endangering criminal or antisocial behavior;
3. Has a Social Security card (if U.S.), and a work permit as required under state or provincial law;
4. Is the son or daughter of a goodstanding Moose member and/or resides with a guardian member;
5. Is willing and able to work hard (and if handicapped, is capable of doing most projects).
