## **Changes to QuickBooks Homepage Format**

Many lodges, and shortly ALL lodges, will have the homepage in QuickBooks change, but it is simply a graphics change. Everything after that page has stayed the same. The new menu is below, and you only need to know a couple of basic things (see screenshot below):

- The previous "+NEW" is now "+Create" (top of the column, just hover your mouse over it to show menu)
- The previous "Transactions" with Chart of Accounts, reconciliations, etc. in a pulldown menu is now "Accounting" with the bowtie icon, near the bottom of the list below. Click on it to get the dropdown.
- "Reports" are still Reports, etc.

## **QuickBooks Online Subscription Price Increases**

Intuit's online QuickBooks Essential subscription pricing has changed effective August 1, 2025. The updated monthly rate for the Essential package has increased to \$75.00 per subscription. Intuit is providing all fraternal units of the Moose a 30% discount, lowering the monthly cost to \$52.50. Previously, Moose International had negotiated a 60-month agreement with an \$8.00 monthly subscription rate. Intuit was unwilling to extend this agreement. Lodges will see the increased cost on their September AR statement, with other fraternal units following in the months ahead, depending on when the first use of QuickBooks online occurred. Moose International is currently exploring more cost-effective solutions for the financial management and accounting of our Lodges, Chapters, Moose Legions and Associations.

## Clarification - New General Laws And Heart of the Community Reporting

Last week's Official Communication included a note on how the new General Laws changes could impact Heart of the Community Reporting. The information below clarifies the information in that note.

The new General Laws (effective 8-01-25) requires that a lodge hosting a Community Service or Charitable Fundraising Event have an approved dispensation on file from the Compliance Office (Sec. 44.3). With this approved dispensation all net funds raised must be submitted to the designated charity.

For contracted charities, such as in Ohio, the lodge is not required to have a dispensation when it is not from a special event and is for their gaming requirement.

If a lodge is making a donation (no fundraiser) to any youth group, veterans home, etc. and the amount is under \$10,000, this only requires a membership vote at a general membership meeting. If the donation or expenditure exceeds \$10,000, then a special meeting as per Sec. 42.3 of the General Laws must be followed. A copy of the special meeting notice, copy of special meeting minutes and a signed dispensation must be submitted before donation is made.

#### 2025 General Law Books

All lodges will receive 10 new General Laws books later this month for the officers of the lodge. Your A/R statement will be billed for the cost. New General Laws books are available from Catalog Sales at this time for \$2.50 each.

## Chastain Looks for Strong Run at Richmond after Another Top 10 Finish

Last Sunday, Ross Chastain qualified fourth during his seventh NASCAR Cup Series start at the upstate New York Watkins Glen road course. He ran as high as second-place and often looked like one of the fastest cars on the track on his way to a 10th-place finish, his 11th top-10 of the season. Surprising no one, Ross's teammate, Shane van Gisbergen, dominated the race as he has done all year on road course tracks.

This week, Chastain makes his 13th Cup Series start at Richmond on Saturday night. Last year in August, Chastain piloted the No. 1 Chevrolet to a fifth-place finish, his second top-five at the Virginia short track. His best Richmond finish came in April 2023 when he finished third. Chastain has led a total of 100 laps in three different Cup races at the .75-mile track.

"I feel like we can go anywhere and compete, we just need to execute. If we can go and get our balance and grip right in practice and qualifying, that sets us up for a good race day. We have won the Richmond 125 a couple of times, but getting all 400 laps has been tough. We've done it a couple of times before and I know we have the ability to do it." – Ross Chastain
