## **QuickBooks Online Subscription Price Increases**

Intuit's online QuickBooks Essential subscription pricing has changed effective August 1, 2025. The updated monthly rate for the Essential package has increased to \$75.00 per subscription. Intuit is providing all fraternal units of the Moose a 30% discount, lowering the monthly cost to \$52.50. Previously, Moose International had negotiated a 60-month agreement with an \$8.00 monthly subscription rate. Intuit was unwilling to extend this agreement. Lodges will see the increased cost on their September AR statement, with other fraternal units following in the months ahead, depending on when the first use of QuickBooks online occurred. Moose International is currently exploring more cost-effective solutions for the financial management and accounting of our Lodges, Chapters, Moose Legions and Associations.

#### Valued Veteran of the Year Submission Due Soon

This is the month that the Valued Veteran's Committee should be selecting the lodge's Valued Veteran of the Year and sending that name in to Moose International. Submit your selection via LCL Web. Click on Forms, Awards, Valued Veteran of the Year 2025. The deadline for this to be submitted on LCL is Sept. 1, 2025. Let's have a Valued Veteran for each lodge! If your lodge does not have a Valued Veteran's Committee, it is up to the lodge officers to pick a Valued Veteran of the Year.

## **New General Laws Impact HOC Reporting**

With the new General Laws now in effect, all community service and fundraising events must have a dispensation on file to get credit on the Heart of the Community report. If a lodge is just giving money to youth sports, a veterans home, or any HOC project <u>and</u> the check does not exceed \$10,000, you do <u>not</u> need a dispensation on file. Make sure when putting this information on the HOC report that you give some background about the group that is receiving the donation. Make sure it is in the proper area of the report. If it is not in the right area, no credit will be given.

#### Chastain Seeks Second Pole at Watkins Glen

On Sunday, Ross Chastain will make his seventh Cup Series start at the 2.45-mile road course in Watkins Glen, NY. Last year, he earned his second Cup career pole position, led the most laps - twice for 51 - in a race that saw three restarts in the final 10 laps plus overtime. Despite his strong performance throughout most of the race, Chastain finished fourth, his best finish at Watkins Glen.

"Road racing has always been such a challenge for me. I've worked so hard on the craft and I've really grown to like it. Having Shane as a teammate has been a great help too. It's wild to watch him in the simulator and how he can be so accurate and smooth with all of his movements. Last year at Watkins Glen, we ran really well. We led a bunch of laps and that was a lot of fun. I'm going to get some extra laps in on Friday in the truck race, which always helps."
