Updated General Laws Go Into Effect August 1st

Delegates to the 137th Meeting of the Moose in Milwaukee this past May passed four voting categories that included changes to the guest policy and updates to other areas such as Special Meetings, Officer requirements and dispensations, among others. Those changes will go into effect on Friday, August 1, 2025. Chastain Races This Week in the Corn Belt

Ross Chastain and the NASCAR Cup Series head to the nation's heartland this week for the Iowa Corn 350 at the Iowa Speedway. (Sunday, August 3rd, 3:30pm on USA network) In last year's inaugural Cup race at Iowa, Chastain started 17th and finished 11th at the .875-mile oval.

Ross's week starts early. On Saturday at Iowa, Chastain will compete in the Xfinity Series race for JR Motorsports while driving the No. 9 Acceptance Insurance Chevrolet, his fifth and final Xfinity race this season.

"The repave is the biggest thing we learned last year at Iowa, trying to learn the new asphalt from the old asphalt. It was tough to pick up quickly. We learned the basement on air pressure

with the tires last year, so our focus this weekend will be on how much the race surface has aged in the last year." – Ross Chastain

Last weekend at Indy, Chastain's Brickyard 400 ended prematurely after a competitor hit him from behind on lap 19 and sent him spinning into the wall. The damage was irreparable and relegated Chastain to a 39th-place finish.
