## Chastain Enters Final Weeks of the 2025 NASCAR Cup Series Season

Ross Chastain finished 23rd in last Sunday's race at Las Vegas Motor Speedway. In the final stage, Chastain had a loose-handling Chevrolet No. 1 Camaro at the beginning and ran in the top-25. With improved handling towards the end of the stage he continued to work his way forward until he received damage from an accident on lap 244 and he was forced to pit multiple times.

Chastain qualified 15th but started the day at the rear of the field due to brushing the wall in qualifying and requiring repairs before the start of the race. In Stage 1 he had an extremely loose handling Chevrolet and went one lap down before recovering late in the stage to finish 35th and on the lead lap.

"It certainly wasn't an ideal finish today for our Chevy. In the final stage of the race, we got the handling figured out and were moving forward, then we got caught up in the accident and had some damage we had to work on. But we rallied to finish 23rd." – Ross Chastain

This weekend, Ross races in the Cup Series' YellaWood 500 at Talladega Superspeedway, the same track where Ross won his first race in the Moose Fraternity Chevrolet. Later this month, on October 26<sup>th</sup>, Ross will sport the red and black Moose Fraternity colors again for a final time in 2025 when he races in the Xfinity 500 at Martinsville Speedway.

Prior to the Martinsville race, Ross will conduct a Meet-and-Greet at the Floyd, Virginia Lodge 2300 at 444 Floyd Hwy South, Floyd, VA from 1-2pm on Saturday, October 25<sup>th</sup>. All members are invited to the lodge at that time to support Ross and the Trackhouse Racing team.

Members looking to cheer Ross on to victory during the YellaWood 500 at the Talladega Superspeedway can catch the race this Sunday, October 19<sup>th</sup> at 2:00pm ET on NBC.
