Chastain Sports Moose Colors for the Last Time in 2025

This Sunday, October 26th, Ross Chastain will sport the red and black Moose Fraternity colors again for a final time in 2025 when he races in the Xfinity 500 at Martinsville Speedway. Few NASCAR fans will ever forget the "Hail Melon" wall ride at Martinsville (Va.) Speedway in October 2022. In the penultimate race of the season, Chastain rode the Martinsville Speedway walls on the final two corners to pass multiple cars and gain entry into the Championship 4 season finale the following weekend at Phoenix Raceway in Avondale, Arizona.

The maneuver, eventually outlawed by NASCAR for safety concerns, drew global praise and recognition as the video eclipsed more than 225 million views, and the event garnered 1.2 billion impressions. The No. 1 Moose Fraternity Chevrolet was the top-selling diecast in 2022, according to Lionel Racing.

Earlier this season, Chastain let the "Moose Loose" at Atlanta, Dover and Bristol, and will continue to represent The Moose for the next two years, thanks to a recent contract extension.

Last weekend, Ross finished 13th at Talladega Superspeedway. Chastain qualified 24th and after a brief surge he dropped back towards the rear of the field. He made a scheduled greenflag pit stop for fuel only on lap 47 but received a pit road speeding penalty. He was able to recover from the penalty and rejoin the pack when the caution came out on lap 53. Ross finished the first stage 16th. He took the lead briefly two different times and raced near the front of the field for many of the final laps.

"It's not often you can leave Talladega in one piece and have a fairly uneventful day so that feels good. We had a pretty good No. 1 Chevrolet today. It was a little tight when I was trying to follow the car in front of me really close but overall it was pretty comfortable to drive. We'll take 13th place and move on to Martinsville next weekend."

Funds Still Available in Local Marketing Grants

The Moose International Board of Directors has approved \$500,000 for the 2025-26 fiscal year to be used as grants back to lodges across the Fraternity to help with local marketing initiatives. Over 120 lodges have taken advantage of the program this year to date, but more funds are still available for lodges looking to sponsor youth teams, participate in local fairs and festivals, march in parades, host community events, and more.

<u>To be eligible</u>: At least one member of the lodge is required to attend the International Moose Convention in Milwaukee in May. At least one member of the lodge was required to be attendance at the lodge's 2024 Association Annual Convention in the Fall; and at least one member of the lodge was required to attend the it's 2025 Association Midyear Conference this past Spring. Lodge must be in good standing and run as a fraternal operation.

The application for the Local Marketing Grant program resides in a pull-down menu in LCL web. The Local Marketing Grant application stays open until the money is depleted or the fiscal year ends, whichever comes sooner.
