Reminder to Use Sponsor Incentive Program Coupon Codes Before June 30

Between November 1, 2025 and April 30, 2026 if you received a one-time use code for sponsoring your fifth (5th) new or re-enrolled member into The Moose, please remember to redeem the code prior to June 30, 2026.

Your code(s) can be used to:

- Pay one year of your own Lodge, WOTM Chapter or Moose Legion dues
- Gift to another member for one year of his/her dues by sharing the code
- Or to sponsor a new or re-enrolling member when using the Online Lodge Membership Application. It covers the cost of the applicant's dues and the \$20 application fee. Note it cannot be used for the current online only application promotion of No Application Fee for Online Applications with Two Year's Dues

Earners received an email from Moose International with a 10-digit code. You or your recipient needs a My Membership Record account to redeem that code for a dues payment under the area labeled Coupons. When using the code for an online application it should be entered in the Payment Information area; click on the drop-down menu for the option to enter the code. Instructions are also included in your email. If you misplace or delete the email with the code, please contact the Helpdesk at (630) 906-3658 for a replacement code.

All codes must be redeemed by June 30, 2026.

Procedure for Alternate Delegates at Convention

Ideally, alternate delegates are needed if no lodge member can go and the lodge has no one to represent them (especially if it is a voting year.) If your lodge has any member registered under your lodge and attending, the lodge gets credit as long as the member attends the sessions and workshops and has their badge scanned in. The lodge needs representation at the meeting in order to qualify for the Premier Lodge Award and any of the grant programs from Moose International. <https://www.mooseintl.org/premier-lodge-award/>

However, any President or Administrator that does not personally attend would miss out on their own personal Lodge Leadership Award. Hope this helps explain it, as many lodges are unsure on how this is used..

If you currently have no registered lodge member attending for your lodge, and you do need an alternate delegate, please submit the letter by Wednesday June 17.

Procedure for Alternates at International Convention

The procedure to have an alternate is as follows: When an alternate has been voted on in a General Membership meeting, he/she shall bring with them a statement on lodge letterhead to present at the **Information booth (located next to registration)** at convention.

The letter shall state that (name) _____, MID # _____ was selected at a General Membership meeting on (Date) 00/00/0000 to be the alternate for Lodge(name) _____ No. _____ at the Moose International Convention.

This letter is to be signed by both the President and Administrator, with the lodge seal applied (if available).

This letter can also be sent ahead of time if the vote has already been made at a Lodge General Membership meeting in order to be more expedient. 2026 Moose of the Year Selection is Open

This program recognizes each Lodge's selection of its most outstanding lodge member (man or woman) as their **Moose of the Year**. Since ALL active members of The Moose may be considered as a Lodge's Moose of the Year nominee, it is our belief that **no Lodge has an excuse to not participate in this recognition program**. Submitting a timely Moose of the Year is one of the criteria for a Lodge to earn the Premier Lodge Award.

The Moose of the Year is selected by the Lodge's Junior Past President, serving as Chairman, and at least three other Past Presidents/Governors of the Lodge. If three (3) active Past Presidents/Governors are not available, the President may appoint other Lodge Officers to the selection committee. Additionally, if the Junior Past President is not available to serve as Chairman, the President may appoint any Past President/Governor of the Lodge to serve in this capacity. The Moose of the Year selection should be based upon the member's overall record as a Moose during the past year, with particular attention paid to their membership efforts, their support of Moose Charities and their contributions to the Lodge and community.

Electronic Submission. The Lodge's Moose of the Year selection will be submitted to Moose International electronically, via LCL Web. **On-line entry is now open and will be accepted through Friday, July 10, 2026**.

As a reminder, Lodges are required to submit a Moose of the Year nominee as part of the criteria for the Premier Lodge Award.

Top Ten Finish for Chastain at Pocono; San Diego Street Course Next

Moose Fraternity NASCAR driver Ross Chastain posted an eighth-place finish last Sunday at Pocono, moving up 16 places from his 24th place starting position. Ross had a quick car at the track, posting four of the fastest laps during the race. His eighth-place finish was his first top 10 at a non-drafting track since Martinsville Speedway in October 2025.

Territory Managers (TM) provide oversight to Moose Lodge operations, promoting programs of The Moose and other units of Moose International; Territory Managers also ensure Moose Lodges and members adhere to the General Laws of Moose International. Territory Managers assist with providing training to association and lodge leaders, as-well-as to Moose members in general. TMs serve as first line representatives of The Moose and all units and departments of Moose International, and provide assistance to members when questions or issues arise.

Territory 40 consists of 28 lodges located within Alberta, Montana and Wyoming-Nebraska Moose Associations. The Territory currently has 23,418 members. The Territory Manager for Territory 40 reports to the Plain West Regional Manager Shawn Schoepp sschoepp@mooseintl.org.

Moose International is not offering any assistance for relocation to this Territory and will not reimburse any expense or cost associated with relocating.
